CHAIR'S REPORT

This year has been a busy one, on the public front of the organisation as well as behind the scenes. After an unprecedented year in 2020 due to COVID-19, Arts Narrogin stepped into 2021 with a clear purpose of resilience. The tireless work of staff and volunteers to continue the trajectory of this organisation certainly has not gone unnoticed, and it is with this support and work that allows Arts Narrogin to be at the forefront of arts and culture in the region.

The new term of the Board began with the sad news of the resignation of our wonderful Manager, Cait Stewart. Cait began as the Administration Officer for the organisation, working hard to promote Arts Narrogin as a progressive regional arts and cultural organisation. As the organisation grew, so too did the need for a managerial position. Cait stepped up to the challenge to take on this exciting position, flourishing in the role and certainly bringing to it more than was expected. The Board, staff, and volunteers certainly felt the loss of her experience, knowledge, and kind nature in the office.

All was not lost, however. After an immense amount of hard work by the Board, Chenique Pensini was appointed to the role of Manager. Chenique's dedication to the organisation, hitting the ground running, is a testament to the entire organisation for its ability to adapt when necessary and continue to be a prominent part of this community.

After accepting a job in Geraldton in August, the Board was tasked with finding another Manager. Having the foundations of the previous work already carried out, the Board was confident in stepping back into the process. It is through this resilience of the organisation that I am confident Arts Narrogin will continue to go from strength to strength in its outreach.

A number of shows, exhibitions and workshops were held throughout the year. A total of eight shows, five exhibitions and six workshops have contributed to date to the organisation's creative calendar for 2021. Arts Narrogin's extensive creative program has meant more exposure for people in the community to the arts and culture, fostering connections, and nurturing the wellbeing of many. A special thanks to those who put in such a great deal of effort to make these things happen, staff and volunteers alike.

Such invaluable support from a range of funding sources has assisted Arts Narrogin to continue its contribution to the community. The Shire of Narrogin increased its annual funding to the organisation in its 2021/22 budget, and the support from our partners, sponsors, businesses, and funding bodies means we continue functioning to serve the community. Such important funding speaks greatly of just how far Arts Narrogin's influence spreads.

I would like to pay special acknowledgements to those who help to make Arts Narrogin the thriving organisation it is. Firstly, to our volunteers. Your efforts to continuously assist where needed, from exhibitions, to events, to workshops, to Arts Space certainly has not gone unnoticed. I want to thank you all for taking the time out of your own lives to give back to this organisation and the community.

To the staff, your dedication to go above and beyond what is expected is a testament to the privilege we have in your involvement with Arts Narrogin. OPERATIONAL REPORT

Creative Program

The last 12 months has seen a busy creative program including live performances, film festivals, exhibitions, community art workshops and artist development workshops - all while continuing to navigate the ongoing effects of the COVID-19 pandemic.

Of particular note, local artists Dianne Strahan and Leith Alexander both held their first solo exhibitions at NEXIS. One of Leith's works became a finalist in the National Photographic Portrait Prize, and Dianne's Print of Place exhibition is one of the most successful selling exhibitions we've seen in recent years.

Award winning choreographer and community engagement whiz Annette Carmichael facilitated an arts collaboration workshop, as part of the statewide Mycelium project. Erin Madeley, owner/operator of Perth Makers Market, delivered a series of three artist development workshops for local creatives and market stallholders. Community visual arts workshops in monoprinting and still life were facilitated by Karen Keeley. And with the enormous efforts of volunteers, moved our workshop venue to the Doney Street premises.

When it comes to film, we saw the return of Flickerfest at the Thornton Theatre, and tested our tastes with a World of Dark Comedy.

For a complete rundown on the performing arts program, please see Brad's debrief in the next section.

Staff

Melanie Noakes joined our team in Feb 2021 in the new role of Volunteer Coordinator, with the purpose of recruiting, managing and training our volunteers to carry out front of house duties at events. Mel also stepped in to take over the role of Finance Officer in April, as we farewelled Katie Chadwick.

Cait Stewart resigned as Manager in March, handing over the reins to Chenique Pensini. In August Chenique accepted a job in Geraldton, and we now look forward to welcoming our new manager, Sylvia Xiao, onto the team in October.

Brad Flett continued in his role as Event Coordinator, managing our expanded performing arts program. Casey Thornton continued as Communications Officer, and in September also took on the previously vacant role of Arts Administration Officer.

RAF Relief

In November 2020, with assistance from Euphorium, Arts Narrogin completed a full overhaul of our existing technology systems and equipment. This was funded by a RAF Relief grant (\$4000) that covered the purchase of new equipment, training and support in technology skills to enable staff, volunteers and the board to work more efficiently, flexibly and remotely.

WA Showcase

In November 2020, three staff (Cait Stewart, Brad Flett and Casey Thornton) attended the WA Showcase conference. Over four days, the best producers and artists in the State pitched a huge range of high-quality work to presenters, and arts workers had an unmissable opportunity for professional development and networking across both performing and visual arts.

In 2021, Circuitwest has offered a travel subsidy for two staff to attend this year's conference. In addition, Arts Narrogin has successfully applied for Regional Arts WA's Community Presenter Professional Development Grant (\$1996) to send a third delegate.

RASI

In November 2020, Arts Narrogin was successful in applying for Regional Arts Sector Investment (RASI) funding. RASI is an open and competitive funding round designed to support regional WA arts and cultural organisations. This grant (\$88,000) over a period of 2.5 years, supports the wages of our Manager for 20 hours per week to deliver our creative program.

In the House

In December 2020, Arts Narrogin was successful in applying for 'In the House' funding (\$157,050), enabling us to present an additional 11 shows over the 2021 and 2022 calendar years. The expanded program builds on the success of the 2019 'Take Your Seats' program, targeting seniors, with a focus on accessibility and community engagement. The additional 23 hours per week of paid staff time to administer the program has enabled the continued employment of Brad Flett as Event Coordinator, and the employment of Melanie Noakes as Volunteer Coordinator.

Of the program attendees surveyed this year, 18% had never previously purchased tickets to an Arts Narrogin event before, which indicates we are continuing to engage with new members of our community & find new audiences of art lovers. It is pleasing to note that 91% of respondents said attending the program made them feel part of the community, and 99% feel it's important that events such as these are available in Narrogin. It comes as no surprise that venue comfort is noted as an area for improvement, and we'll continue to navigate the challenges surrounding shows programmed in winter.

Because of You

In September 2021, Arts Narrogin was successful in applying for Creative Communities COVID-19 Recovery funding. This grant (\$30,000) will fund a child-centred dance residency project created by choreographer Sandi Woo and Annette Carmichael Projects, in June/July 2022. *Because of You* is a project that celebrates the relationship between children and parents, grandparents or carers using play-based dance, film, visual design and original music.

We are incredibly excited to be hosting this residency project in our community, and along with a few other things we have up our sleeve, it should make for an absolute cracker of a year!

PERFORMING ARTS DEBRIEF

Djuki Mala

Two workshops were conducted in Narrogin prior to the main performance with good support from local indigenous and Avon Youth group. Two Welcome to Country's were conducted by local elders including a special smoking ceremony at the reserve.

30% of the audience tickets were gifted to the local indigenous community, specifically for elders and their grandchildren. A sausage sizzle was also held in Mackie Park, prior to the main performance where all locals gathered.

A magnificent performance in terms of the technical perspective but most importantly the audience experienced a passionate and informative expression of dance and sense of community.

This was received with great humbleness by the locals as conveyed by comments post show from the Elders which they felt demonstrated how their community could come together to create and share their story in a similar way.

Sense and Spontaneity

After waiting a year for this production due to COVID-19, the two ladies performed to a captive and raucous audience. Their improve style and obvious talent had everyone in fits of laughter! Both actors commented that Narrogin was their most funniest to date! What a great way to begin events again.

Don't Shoot Me, I'm Only the Piano Player

Arts Narrogin had the pleasure of hosting David Scheel at the Reception Centre to a COVID-19 restricted sell out. It was great to be able to utilise the Baby Grande piano for this event which David played skillfully and the sounds were beautiful. David's wit within his ballads and the way he played two classics simultaneously (one with each hand!) demonstrated his talent. He's the consummate professional despite being unwell. Narrogin's classical piano lovers were well and truly treated.

Sue Bluck presents Feeling Good

Arts Narrogin hosted the talented Sue Bluck and much credentialed quartet at the Narrogin Town Hall. Thankfully this coincided with our new Technical guru, Kevin Blythe coming on board which resulted in a great sound. Sue Bluck noted herself, that she'd never sounded so good.

A modest winter braving-crowd enjoyed two sets of magnificent renditions of iconic women in piano and song! The third set was played to an audience who were busting to dance. Even our very own life member, Peter Taylor was treading the boards and tripping the light fantastic!



Indigo Sand

Performed at the Narrogin High Senior School Performing Arts Centre, these two wonderful ladies performed such a graceful, clever piece of storytelling with puppetry, painting and movement.

A small but engaged audience of children including indigenous and special needs children with their families in attendance witnessed a timeless performance.

Miss Westralia

After a long wait due to COVID-19, Miss Westralia finally hit Narrogin! We had planned a (pre-performance) community engagement session with cast and crew at the Gnarojin Community Gardens. However due to a very cold and windy day, we relocated to the Arts Space office. Approximately 30 clients of Jesse House and residents of Karinya were present along with the Shire President and other Shire delegates. We were treated to a scrumptious morning tea provided by the Narrogin CWA. We were then entertained with four songs performed by the cast. This was interspersed with great conversations and stories of Beryl Mills, the production and their tour - from cast, staff and members of Arts Narrogin and Julian Canny from Euphorium.

The performance that same evening was almost a sell out! Jesse Layman provided the amazing spread of food which only added to the seamlessness of the entire event. The production quality and the performance in general was more than expected. I'd witnessed this production at Showcase two years prior and it was all that I remembered and more.

As recently as last week, I spoke with Circuitwest who had completed their acquittal for the tour. Feedback from the production is that Arts Narrogin was head and shoulders above any other venue/community on this tour for community engagement, attendance and hosting in general. A great achievement BY ALL Arts Narrogin Staff and Volunteers!!!

Every Brilliant Thing

A difficult and challenging production to pitch to Narrogin's community and it's professionals as it turned out. I went about writing to all of the health professionals and organisations including mental health and indigenous groups within our district. (49 in total were contacted directly). From that contact only four (4) responded and attended including Terry Melrose from Regional Men's Health and James Gibson from Holyoake. I have to say I was surprised at the apathy demonstrated from the poor response but at the same time was incredibly proud to be a part of an organization (Arts Narrogin) that were prepared to go out on a limb to host such a valuable event. Which was exemplified by the feedback directly from the audience members and Black Swan hierarchy.

Arts Narrogin took the initiative to contact DFES and WAPOL, given the recent suicides in this region within their departments. A letter of support was provided by Black Swan and Care Australia to Arts Narrogin to issue to these departments, resulting in approximately 25% of our audience, who were first time Arts Narrogin events attendees. These are our emergency first responders in our district.

The audience that remained post show enjoyed conversations with cast, crew and the mental health providers/counsellors that attended. Another delicious supper provided by Narrogin CWA! Great way to end a very valuable evening for the community.

It should be noted that our photographs taken by Caro Telfer of the night have been used by Black Swan to promote the four week residency at the State Theatre and ensuing four major town regional tour.

On a personal note -

I would personally like to thank every single person that has been involved with any of these productions, this past year particularly. With special mentions to my awesome co-workers, Casey and Mel and all of our volunteers. You know who you are! You are valued and loved and are an integral part of the events calendar for Arts Narrogin. Its clear Arts Narrogin puts on a great event from all the feedback we've received from production crew, cast and coordinators alike.

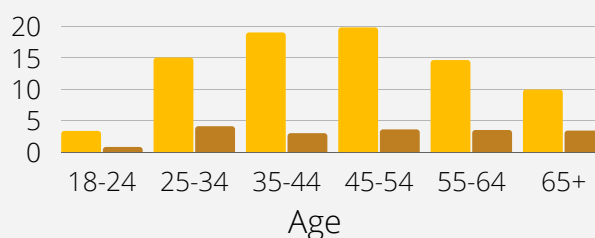

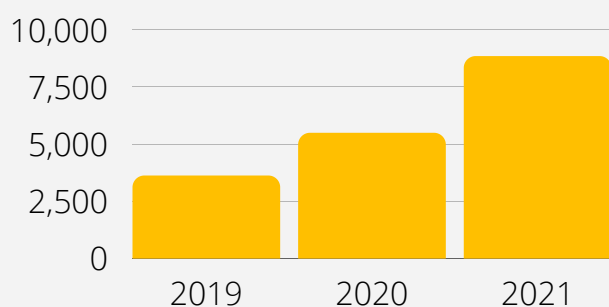

WEBSITE VIEWS

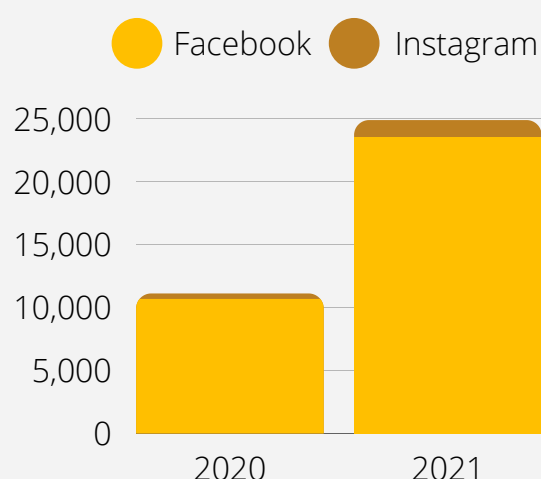


It's incredibly pleasing to note website views have increased 66% compared to 2020, and astoundingly, have more than doubled since the redesign of our website in early 2019.

2021 average monthly page views = 816.

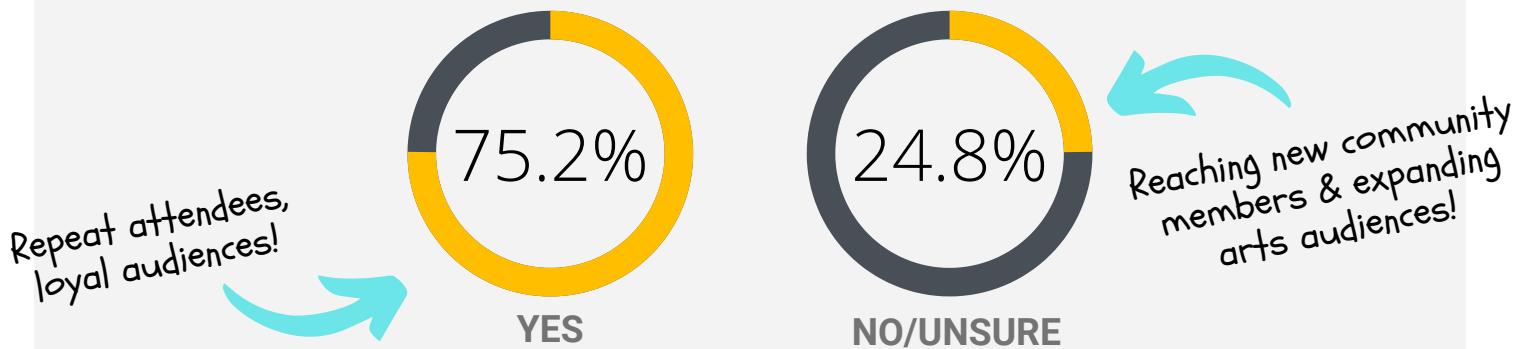
SOCIAL MEDIA REACH

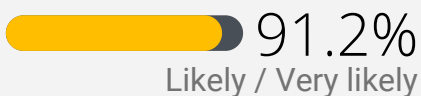
HAVE YOU ATTENDED AN ARTS NARROGIN EVENT BEFORE?

Attending this event made me feel part of the community

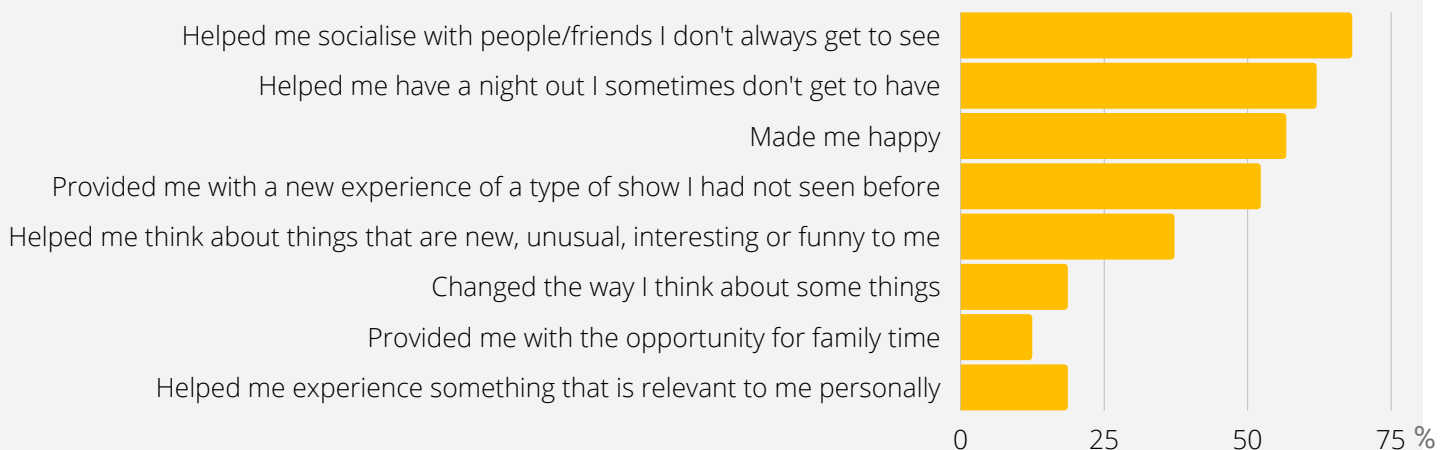
HOW DID YOU FIND THE COMFORT OF THE VENUE?

FINANCIAL REPORT

Arts Narrogin has this year transitioned to a Tier 2 Not for Profit organization, ie our revenue is now between \$250,000 and 1 million per year. As well as providing a profit and loss statement and balance sheet (See following reports) we engaged Audit Partners Australia once again but this time to conduct an Annual Audit. As at 7/10/2021 the audit is still in progress. The final report will be made available as soon as the audit is complete.

Our accounting program XERO has been well received and we are still receiving amazing support from RSM Narrogin, in particular Felicity Taylor. This has been tremendously appreciated so many thanks to Felicity and her team.

Our financial reporting breakdown is as follows:

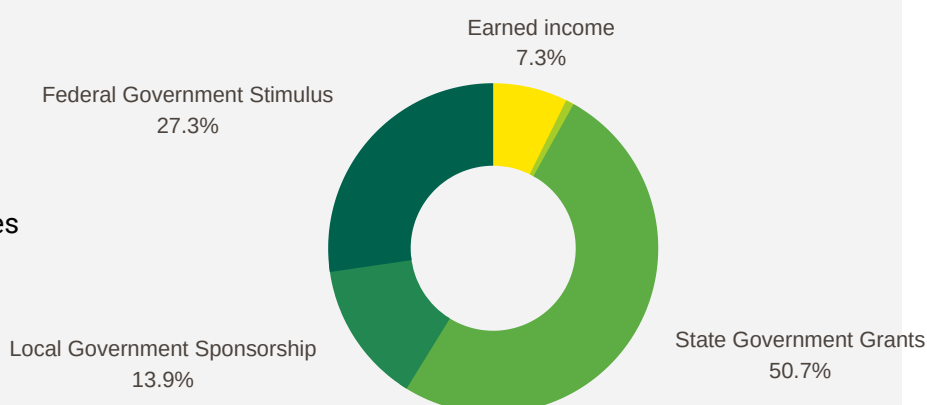
Income

Fifty percent (50%) of our income for the year came from State Government Grants. This consisted of:

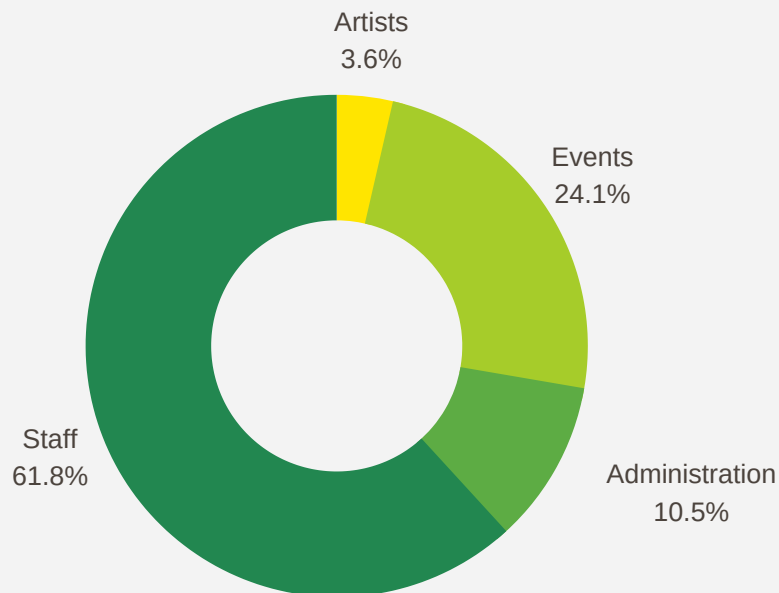
- Regional Arts Sector Investment Funding \$23,322 (via Country Arts WA & Regional Arts WA)
- Department of Local Government Sport and Cultural Industries \$157,050 (Take Your Seats, formerly In the house)
- Drug Aware YCulture - Music for the soul \$3,185
- Drug Aware YCulture - Paint of heart \$2,484
- Regional Arts WA - Regional Arts fund relief grant \$4,000 (Tech Grant)

7.3% of our income was earned through providing a Regional Hub for Country Arts WA, membership, events, workshops, commission on sale of art work, book sales and bank interest.

13.9% came from the Shire of Narrogin in baseline financial support for our organization, 27.3% as a result of the Federal Government's stimulus package (COVID 19 related) in Job Keeper support and a Cashflow boost and 1% from philanthropy.

Expenditure

Our expenditure (\$196,925.15) is represented as follows:

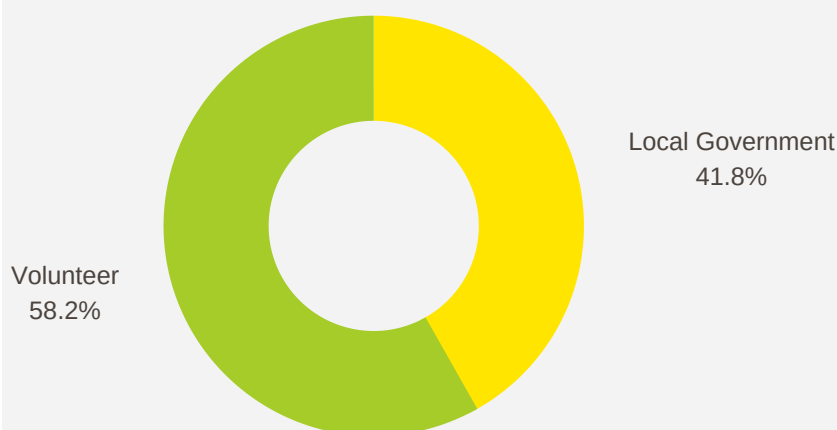
At 62% of our expenditure, our largest expense this year was staffing, this allowed us to apply for funding, rework our financial accounting system, update policies and run our creative program.

Administration costs were just over 10% of our total expenditure and 3.6% was paid out to local artists which also included the Narrogin Repertory Club tickets sales.

After a very successful year of shows and workshops, just over 24% of our expenditure came from our events which supported local businesses with venue hire, accommodation, catering and advertising.

In-Kind Contribution

Our \$value for in-kind contributions of \$124320 is represented by 2,260 volunteer hours and the in-kind contribution from the Shire of Narrogin is in subsidized rent for our premises.



I would like to thank our wonderful volunteers and staff for a successful year and a special mention to our former finance officer Katie Chadwick for her amazing support that she has provided me since taking on this role. It is greatly appreciated.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2015 (WA). The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a) Income Tax

The Association is a non-profit organisation and thus exempted from income tax liability by virtue of 23(3) of the Income Tax Assessment Act.

b) Fixed Assets

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use. Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

c) Goods & Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.
